Executive Summary:

This report is to present the submissions received in relation to the draft 2018/2019 Budget

- Council resolved on the 3 April 2018 to release the draft budget for public exhibition
- A person has a right to make a submission under section 223 of the Local Government Act 1989 (the Act), on any proposal contained within the draft budget.
- A total of five submissions were received in relation to the draft 2018/19 budget.



 It is recommended that Council notes and considers these submissions prior to adopting the 2018/2019 Budget at the Ordinary Council Meeting on Monday 4 June 2018.

Declaration of Interests:

The Manager Finance declared an indirect conflict of interest under section 78B of the *Local Government Act 1989*. In order to ensure unbiased advice to Council, a process has been implemented to ensure that the Manager Finance has been excluded from providing or including any advice in this report associated with the area of the declared indirect conflict.

Background:

On 3 April 2018, Council resolved to give notice of preparation of the proposed 2018/2019 Budget and to allow a period of 28 days for submissions.

A person has a right to make a submission under section 223 of the *Local Government Act 1989*, on any proposal contained within these documents.

Public notice of the preparation of the Budget was subsequently advertised in the Latrobe Valley Express on 5 April 2018 and 12 April 2018, advising that the budget documents were available for inspection at Council's service centres and on Council's website.

Submissions in relation to the Budget were receivable up to 5pm on 2 May 2018. A person who has made a written submission to Council and requested that he or she be heard in support of the written submission is entitled to appear in person before a meeting of the Council. In the public notice Council indicated that written budget submissions would be considered and submitters would have an opportunity to speak to their submissions at a Special Council meeting to be held at 6.00 pm on Tuesday 15 May 2018.

A total of five submissions have been received in relation to the draft 2018/2019 Budget. Those wishing to speak to their submission will have the opportunity to do so at the Special Council Meeting.

A copy of each submission received has been provided to Councillors, and a summary of the submissions is provided below along with those intending to speak to their submission.
