Secondary Consent Request Form

Typically a planning permit will contain the following condition: *The development as shown on the endorsed plans must not be altered without the written consent of the Responsible Authority.*

This condition allows for minor modifications to the endorsed plans, subject to the written consent of the Responsible Authority, commonly known as secondary consent. The owner or occupier may request secondary consent where changes are proposed to the plans only.

Please Note: a secondary consent is not approved automatically as Council must consider a range of criteria, including whether the proposed changes conflict with the permit preamble or conditions, would be beyond the ambit of discretion of the original approval or would potentially cause material detriment and require advertising. In such cases the secondary consent process may not be used – An Application to Amend a Planning Permit should be made to Council under section 72 of the Act (if the permit was issued by Council) or to the Tribunal under Section 87A (if the permit was issued by VCAT).
