9.5 2016/24 REMOVAL OF BURGAN

I, Cr Middlemiss, hereby give notice of my intention to move the following motion at the Council Meeting to be held on Monday, 22 August 2016:

That Council seeks a Planning Scheme Amendment that will enable Council to; upon the recommendation of a duly appointed council environmental officer issue a permit for the removal of Burgan (kunzea ericoides) in the following circumstances:

- 1. Burgan encroachment upon council flora reserves which threatens the indigenous bio diversity of those reserves.
- 2. Burgan encroachment upon previously cleared farmland or rural living properties or council properties.
- 3. Burgan encroachment upon council road side reserves or council properties where it threatens indigenous bio diversity or is considered a fire hazard or is considered a traffic hazard or threatens the intended use of the property.
